- a junction with Public Footpaths BA8/25, BA8/77 and BA8/81 at grid reference ST 6497 6291 and continuing in a generally easterly direction for approximately 152 metres to grid reference ST 6511 6289,
- grid reference ST 6494 6285 and continuing in a generally north easterly direction for approximately 84 metres to a junction with Public Footpaths BA8/25, BA8/26 and BA8/81 at grid reference ST 6497 6291,

- a junction with Public Footpath BA8/77 at grid reference ST 6494 6285 and continuing in a generally westerly direction for approximately 40 metres to grid reference ST 6490 6286.
- a junction with Public Footpath BA8/81 at grid reference ST 6488 6294 and continuing in a generally southerly direction for approximately 83 metres to grid reference ST 6490 6286,
