# BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATHS BA8/25, BA8/26, BA8/77 AND BA8/81, WICK FARM, COMPTON DANDO) PUBLIC PATH DIVERSION ORDER 2017

This order is made by Bath and North East Somerset Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owners of the land crossed by the footpaths described in paragraph 1 of this order it is expedient that the line of the paths should be diverted.

Mr and Mrs Warren of Wick Farm have agreed to defray any expenses which are incurred in bringing the new site of the paths into a fit condition for use by the public.


#### BY THIS ORDER:

- 1. The public rights of way over the land situated at Wick Farm in Compton Dando and shown by bold continuous lines on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up from the date that the authority certifies that work has been carried out to bring the site of the new highways mentioned in Article 3 into a fit condition for use by the public.
- No statutory undertakers rights are affected by this order.
- 3. There shall, on the date on which the authority certifies that the works to bring the new site of the paths described in Part 2 of the Schedule into a fit condition for use by the public have been completed to the reasonable satisfaction of the authority, be public footpaths over the land situated at Wick Farm in Compton Dando described in Part 2 of the Schedule and shown by bold broken lines on the map attached to this order.
- 4. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

#### PART 1

# **DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

The full width of a section of Public Footpath BA8/25 commencing from a junction with Public Footpaths BA8/26, BA8/77 and BA8/81 at grid reference ST 6497 6291 (point G on the Order Map) and continuing in a generally north westerly direction for approximately 229 metres to grid reference ST 6490 6313 (point P on the Order Map) and turning in a generally westerly direction for approximately 21 metres to a point where the footpath turns in a northerly direction at grid reference ST 6488 6314 (point A on the Order Map).

The full width of a section of Public Footpath BA8/26 commencing from a junction with Public Footpaths BA8/25, BA8/77 and BA8/81 at grid reference ST 6497 6291 (point G on the Order Map) and continuing in a generally easterly direction for approximately 152 metres to grid reference ST 6511 6289 (point F on the Order Map).

The full width of a section of Public Footpath BA8/77 commencing from grid reference ST 6494 6285 (point D on the Order Map) and continuing in a generally north easterly direction for approximately 84 metres to a junction with Public Footpaths BA8/25, BA8/26 and BA8/81 at grid reference ST 6497 6291 (point G on the Order Map).

The full width of a section of Public Footpath BA8/81 commencing from grid reference ST 6488 6294 (point B on the Order Map) and continuing in a generally easterly direction for approximately 96 metres to a junction with Public Footpaths BA8/25, BA8/77 and BA8/26 at grid reference ST 6497 6291 (point G on the Order Map).

# **DESCRIPTION OF SITE OF NEW PATH OR WAY**

A section of public footpath commencing from a junction with Public Footpath BA8/81 at grid reference ST 6488 6294 (point B on the Order Map) and continuing in a generally northerly direction for approximately 196 metres to a junction with Public Footpath BA8/25 at grid reference ST 6488 6314 (point A on the Order Map).

Width: 2 metres

A section of public footpath commencing from a junction with Public Footpath BA8/77 at grid reference ST 6494 6285 (point D on the Order Map) and continuing in a generally easterly direction for approximately 166 metres to grid reference ST 6509 6282 (point E on the Order Map) and turning in a generally northerly direction for approximately 87 metres to a junction with Public Footpath BA8/26 at grid reference ST 6511 6289 (point F on the Order Map).

Width: 2 metres

A section of public footpath commencing from a junction with Public Footpath BA8/77 at grid reference ST 6494 6285 (point D on the Order Map) and continuing in a generally westerly direction for approximately 40 metres to grid reference ST 6490 6286 (point C on the Order Map).

Width: 2 metres

A section of public footpath commencing from a junction with Public Footpath BA8/81 at grid reference ST 6488 6294 (point B on the Order Map) and continuing in a generally southerly direction for approximately 83 metres to grid reference ST 6490 6286 (point C on the Order Map).

Width: 2 metres
